CONTRACTORS / SUB-CONTRACTORS LICENSE REQUIREMENTS

1. \$10,000 Surety bond in the name of the Village of Riverside
2. Certificate of Insurance with Village of Riverside named as certificate holder, not less than \$1,000,000
3. Proof of Workmanø Comp (if required by the State)
4. Completed application for contractorø license (\$100.00 fee, valid for one year from date of issuance)
5. Copy of State/local license (electrician, roofer, etc.)

The Village will accept faxed copies from the insurance company, but the ORIGINAL of the surety bond must be received before the permit is issued.
