Opening day for the 2018 Riverside Farmers' Market is Wednesday, June 6. The market will be held next to the historic Riverside Water Tower (10 Pine Ave/north of the railroad tracks). In addition to our wonderful vendors, the market will feature a community table, a local business table and a variety of programming each week. Sign up early to ensure that your local organization has a chance to participate. The Farmers' Market will be held every Wednesday from 2:30 - 7:00 p.m. starting June 6 and ending October 10, 2018.

There is no cost to your group to host the community table at the market; however, you must apply in advance and provide the village with a **certificate of insurance**. Your written certificate of insurance for liability coverage in the amount of \$1 million must have the Village of Riverside named as an additional insured. The village will provide a table and chairs. Once we receive your completed application and certificate of insurance, we will send you a link that you can use to select a date that works best for you. We ask that you initially select **only one slot** until others have had a chance to sign up. Please email us for approval to sign up for an additional date at the market.

This is a great opportunity for your organization to let the community know about the projects and initiatives your group is involved in. Do you have an upcoming event that you want to publicize? Hosting the Community Table at the Farmers' Market is a great way to get the word out.
