Old Business:

Colin Hughes – Colin was sworn in at the previous Village Board of Trustees meeting. He will be a TV Commissioner for the remainder of the term started by Commissioner Wojcik.

LAC Video — Supervisor Doria reported that the LAC Video was in edit, and that the video still needed additional photos and content. The editor was currently out due to a positive Covid 19 test. Doria informed the LAC that the job would be postponed for approximately 2 weeks.

EDC – Focus on Business — Chair Gorski asked for an update on this. Supervisor Doria informed the Commission that due to the Covid 19 Virus Quarantine, the business videos for the EDC have been put on hold.

Riverside Minutes – Update —On hold. Commissioner Yurkiw would work on new concepts for the series.

New Business

Township Of Riverside Senior Exercise Video Series – The Township of Riverside series of Senior Exercise Videos had over 30 shows produced. The shoots for the township of Riverside Senior Exercise Classes will resume on March 7, 2021 followed by the Yoga Classes on March 14, 2021.

Crewmembers - Update — Chair Gorski asked for an update on this. Caden Sierra has been hired and was working with the crew, after some training by Director Cordova. Tech Director Cordova let the commission know there was a new applicant for the crew that would be applying soon from RBHS. Doria explained the Suspension of work by Michael DeLeonardis and Jason Valley due to the Covid 19 positive test for DeLeonardis.

Cloud Storage – The issue of cloud storage for the RTV Archives was discussed. Doria stated that he discussed the need for storage with the Village Manager and was directed to the Finance Director and the IT contractor for the village. Doria had contacted them twice but had not heard back from them. He said he would try again. Commissioner Hughes said the current need was for 30TB of data. He had researched 3 different storage systems that ranged in price from \$16K - \$22K. Doria also mentioned that the village manager had asked that the village offices have access to the RTV files.

Equipment Update — Doria reported the purchase of a new analog mixer, a four channel portable recorder, and other audio converters and cables.

WCCA Meetings – WCCA – Commissioner Hughes will contact the Village Manager regarding the schedule for the WCCA Meetings.

Joe Ballerine suggested we look for an app that could call up any of the WCCA partner videos. He also suggested new videos be made to introduce and show bios for the Village Trustees and also videos to explain the various village commissions.

Saturday Morning Programming – Update — Director Cordova stated that he has rotated the cartoon blocks on the channel. Movies are “Cyrano DE Bergerac”, and “Hell Town”. Commissioner Yurkiw said he would look for additional movies.
