Old Business

LAC Video — Supervisor Doria reported that the LAC Video was in edit, and that the video still needed additional photos and content. Doria is in talks with Cathy Maloney, LAC Chairman about obtaining the needed content.

EDC – Focus on Business — Chair Gorski asked for an update on this. Supervisor Doria informed the Commission that due to the Covid 19 Virus Quarantine, and the lack of personnel at the Village Office, the series is on hold.

Township Senior Exercise Video Series – Supervisor Doria stated that the Riverside Township video series is at its end for now. 4 new shows featuring yoga were filmed and 4 new shows featuring a different instructor and gym had also been filmed.

Parks and Rec Video – Doria reported that the video had some revisions and that it was now ready to post. The video had been approved and complimented by the Village Manager and the Parks and Rec Director.

Tribute Video – The tribute video for Chief Weitzel was in edit and would be presented to the chief at the next VBOT Meeting.

Riverside Minutes – Riverside Minutes is on hold until new concepts are developed and the weather is more favorable.

RTV Vehicle – Doria reported that the village was searching for a vehicle for RTV.

New Business

North Riverside BOT Meetings – No new information has been reported on RTV covering the North Riverside BOT meetings.

2021 Kayak Regatta – Supervisor Doria reported that after discussing this event with the Village Manager, he was told that the event sponsors needed to fill out the Village Filming Application. The commissioners decided they needed to create a list, which showed the community events that would be paid by the village and which would need to be paid for by their sponsors. Trustee Gallegos asked for a copy of the application.

Lantern Night – Supervisor Doria reported that after discussing this event with the Village Manager, he was told that the event sponsors needed to fill out the Village Filming Application. The commissioners decided they needed to create a list, which showed the community events that would be paid by the village and which would need to be paid by their sponsors. Trustee Gallegos asked for a copy of the application.

Hybrid VBOT Meeting – Director Cordova reported that the meeting had some issues in the beginning but that was corrected early and the remainder of the meeting was successful.

Trustee Meetings at Parks and Rec Facility – Doria and Cordova reported that the P&R facility was suggested as a venue for the VBOT meetings. After the Village President and Manager were informed that RTV could not broadcast live from that location, the venue was dropped from the meeting location list.

Filming Application – The application was discussed and Chairman Gorski said he and the commissioners would work on a list of village events that they believe should be paid for by the village. Commissioner Hughes suggested the list should be available at the beginning of each year.

RTV Crew Member Recognition – Director Cordova let the commission know about a scholarship that was awarded to RTV crewmember, Zach Cameron.

Assistant Village Manager – Director Cordova informed the commissioners that an Assistant Village Manager was hired and once in office, she would be the liaison between the TV Commission and the Village.

Commissioner Koncius – Stated she was working towards projects with her students that would bring content to RTV.

Crewmembers - Update — Chair Gorski asked for an update on this. Doria told the commission that there was a new crewmember, Michael Duzek, a student at RBHS. Doria also said he was waiting on the processing of an application from an OPRFHS student, Jake Di Maso.

Cloud Storage – The issue of cloud storage for the RTV Archives is still waiting for an answer from the Finance Director and the IT manager for the village.

Equipment Update — Doria informed the commission that new cables and a battery charger were purchased.

July 4 Parade – Doria and Cordova told the commission that the parade would be revised for this year and that info should be available after the next VBOT meeting.

RAW – Doria and Cordova explained to the commission that RAW was going to produce the RAW Spectacle only for 2021. The shoot is scheduled for June 12, 2021.

Saturday Morning Programming – Commissioner Yurkiw is working on new material for the movies and cartoons. He said he would drop material off at the RTV office.

“A Star Is Born” will be up soon. Director Cordova asked that someone screen the films to make sure they are appropriate to show on our channels.
