Vehicle Stickers & Dog Licenses Renew in May

Renewal forms will be mailed to residents in mid-May. Stickers must be purchased and displayed no later than June 30 to avoid penalties. Current stickers are required for all vehicles housed in Riverside <u>or</u> registered (with the Secretary of State) to a Riverside address. Renewals with no changes can be renewed on-line before June 20. You may also return your renewals by mail or use the silver drop box in front of the village office. We will process your paperwork and mail your stickers to you. Please consider using these convenient renewal options rather than standing in line at the Village office.

If your vehicle is no longer registered or housed in Riverside, you must provide the village with a copy of the bill of sale or other disposal record such as an insurance report or Secretary of State registration showing that the vehicle is no longer registered in Riverside. If a vehicle remains registered in Riverside but is used or stored out of town (such as with a college student or at second home), it still must have a Riverside vehicle sticker. Dog owners must provide proof of current rabies inoculation. All dogs must be licensed.

Yard Waste Guidelines

Yard Waste Pick-Up

Yard waste includes grass clippings, weeds, leaves, branches, brush, shrubs, vines and any greenery produced from gardening and landscaping. Residents are encouraged to look for alternatives to bagging yard waste for collection such as mulching mowers, leaf shredders and backyard compost piles.

For residents who wish to have their yard waste collected, please note the following:

- Yard waste must be placed in paper yard waste bags up to 35 gallons and 50 pounds; or
- Sturdy plastic or metal containers up to 35-gallons marked in a large letters for yard waste free *Yard Waste Only* decals are available at Village Office. Containers must have two handles and must weigh no more than 50 pounds when filled.
- Bundled brush up to two feet in diameter and four feet in length weighing no more than 50 pounds is also acceptable. (The diameter of individual branches should not exceed 3 inches.) Brush must be securely bundled with natural rope or twine. Unbundled brush will not be collected.

Collection Guidelines

- Yard waste is collected from the first week in April through the last week of November. Yard waste is collected on Tuesday as long as it is placed at your collection point by 6 a.m.
- Any yard waste mixed with trash or placed in plastic bags or a garbage cart will not be collected. Please do not mix dirt, rocks, stone with yard waste.

Riverside Property Transfer Requirements



The Village of Riverside requires property owners to obtain a Certificate of Compliance whenever title is transferred for a structure, building or dwelling unit. The expense is the seller's responsibility, and the Certificate of Compliance must be given to the new owner at the time of closing. An original stamped plat of survey which is not more than six months old must be provided to the Building Department in order for the Certificate of Compliance to be issued. The compliance inspection should be scheduled at least one week before the proposed closing date, but residents are encouraged to contact the Building Department as soon as the closing is scheduled. The cost of the Certificate of Compliance

depends on the type of property; however, for a single family home the cost is \$175 plus payment of the final water bill and any other outstanding debts owed to the village. Please contact the Building Department at (708) 447-1241 with questions or to set up a Compliance Inspection. Fire Department offers CPR Classes

The early initiation of quality CPR has proven to increase the survival rate of patients who suffer a cardiac arrest. Combining CPR with early defibrillation and advanced life support has proven to save lives. The Riverside Fire Department will conduct CPR classes for the general public on April 15 and May 27, 2013. The Heart Saver course (General Public), is approximately 3 hours. All CPR classes are American Heart Association (AHA) Classes, and are authorized through Edward Hospital EMS System. CPR Certification Cards will be issued at the end of the



class, pending successful mastery of skills. Participants must register in advance by calling the Riverside Fire Department at 708-442-2251, ext. 312.

Landscape Workdays for 2013

The Riverside Public Works Department, Parks & Recreation Department and the Olmsted Society are teaming up in 2013 to beautify Riverside's public parks. Scottswood Common and the Longcommon serve as the backbone of Riverside's landscape architecture. Both were intended to be part of a green space stretching all the way to downtown Chicago. Frederick Law Olmsted designed the parks to provide changing vistas for both pedestrians and vehicles.

His plan can be better realized by reducing shrub overgrowth and eliminating weeds. Landscape Workdays for 2013 are: April 27 at Patriots Park, May 11 at the Scout Cabin, June 1 at Blythe Park, June 22 at Big Ball Park, July 13 at Scottswood Common, August 3 at Harrington Park, August 24, September 7 and September 14 at Gage Road and Riverside Road along the Des Plaines River, October 5, October 26 and November 9 at Big Ball Park. Village's Bond Rating Upgraded to AA+

The Village of Riverside was notified by Standard & Poor that it has assigned the Village a bond rating of AA+. Standard & Poor's rating was based on the following observations of the village: participation in the deep and diverse Chicago metropolitan area economy; very Strong incomes and extremely strong market value per capita; very strong reserves and a history of operating surpluses; and moderate overall debt burden, coupled with rapid amortization. S&P's assessment of the Village's financial management practices is classified as 'good' under its financial management assessment (FMA) methodology. Areas of note include the monthly budget-to-actual performance reports to the board, long-term financial and capital plans, and the long-standing formal fund balance policy to maintain 25% of expenditures in general fund reserves.
